- WHEREAS, in accordance with Alaska Statute 14.14.060(c) and KPB 5.04.021 the School District ("KPBSD") shall submit the school budget for approval of the total amount and the assembly must determine the total amount of money to be made available from local sources for school purposes and must furnish to the school board a statement of the sum to be made available within 30 days of receipt of the budget; and
- **WHEREAS,** the borough is proposing that school funding from local sources for FY2018 be \$49,738,432;
